ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Koti Mize on 22.02.2023 filed an RTI application in Form-A to the PIO cum PD DRDA Boleng Siang District A.P., whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum Deputy Commissioner Boleng Siang District on 20.04.2023.

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh information Commission on 27.07.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.722/2023 (Appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for hearing before the Commission Court today on 16.08.2024. Notice of hearing dated 28.06.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 16.8.2024 the respondents PIO Shri Jacob Tabing, PD DRDA Boleng Siang District AP is present. The appellant Shri Koti Mize did not appear.

Heard the PIO.

PIO states that he has brought the balance information required by the appellant at RTI application form A in the commission court today. But it could not handover the same as the appellant was not there to collect the information.

The commission pursued this appeal case file records. It is seen that on first hearing dated 30.11.203 the appellant stated that partial information was already received by him.

After hearing the PIO and pursuing case file records an ex-parte decision is taken. The appellant is directed to collect information from the PIO's office with delivery of a copy of this order to the PIO. The PIO shall obtain receipt acknowledgement from the appellant and submit a copy of it to this commission. If any shortcoming / incorrect information is found, appellant may file a written submission to the PIO with specific mention of the shortcoming and obtain a receipt from PIO's office and submit a copy of it to this commission.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report of above direction from PIO and appellant.

Judgement / Order pronounced in the Open Court of this Commission today this 16<sup>th</sup> day of August 2024. Each copy of the Judgement / Order be furnished to the parties.
