To

The PIO(EE,PWD)Sangram Division, Kurung Kumey District, Arunachal Pradesh.

- 1. One Shri Bengia Raju has filed the Second Appeal against the PIO (EE,PWD) Sangram Division, Kurung Kumey District, before the Arunachal Pradesh Information Commission, Itanagar, on 01/09/2023 U/S 19 (3) of RTI Act, 2005 vide Appeal No. APIC-856/2023, wherein, alleging against the concerned PIO that he has failed to furnish information(s) sought by him under 'Form-A', of his application dated 05.06.2023 relating to the matter as quoted in Form-A application.
- 2. The case is still ongoing in the Commissions' Court. The case was last heard on 22<sup>nd</sup> March, 2024 but you were found absent, nor did you send any representative on your behalf to appear before the Commission, whereas the appellant Shri Bengia Raju was present.
- 3. The Commission seriously viewed your absence and inclined to ask you to show cause as to why you should not be imposed a reasonable penalty as provided in the Section 20(1) of the RTI Act 2005 for violation of Sub Section (1) of the Section 7 of the RTI Act,2005 and also invoke the Section 20(2) of the RTI Act,2005 against you.
- 4. Therefore, you are once again directed to appear in person on 7<sup>th</sup> June,2024 at 1400 hrs(02.00 PM)alongwith all the replies to the information(s) sought by the appellant and the reason(s) of your absence during the last hearing of this case held on 22<sup>nd</sup> March,2024 before the Commission (APIC).
