## ORDER

- 1). This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Lekhi Village, Near Iconic Dealer, PO/PS Nirjuli, Papum Pare District, Arunachal Pradesh for non-furnishing of information by the PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 on 07/03/2022 regarding the details of appointment orders of PTI & PTI Grade-II, PTT, PET, PRT, TGT.
- 2). The 17<sup>th</sup> re-scheduled hearing was held on 29<sup>th</sup> April, 2025. Shri Kocho Jomoh, the PIO –cum-DDSE, Govt. of A.P., Ziro, Lower Subansiri District, Arunachal Pradesh and the Appellant Shri Nabam Tapak were present in the Court.
- 3). The PIO submitted that all the available information under the jurisdiction of DDSE, Ziro, Lower Subansiri District had already been furnished by the previous PIO. The additional information that had been transferred to Raga, Kamle District after bifurcation of district have now been collected from Raga, Kamle District Coordinator and brought to be furnished to the Appellant.
- 4). The Appellant received the information and submitted that the information furnished seems to be incomplete.
- 5). The Commission directed both the parties to sit together outside the court room and sort out the information which were not furnished. The Appellant was also, directed to give list of unfurnished information to the PIO and the Commission.
- 6). The Commission further directed the FIO to furnish all the available information within his jurisdiction, if not, under section 6 (3) of the RTI Act, 2005 forward the application to the concern PIO or give justifiable statement through AFFIDAVIT.
- 7). The Commission to ascertain satisfactory furnishing of information to the Appellant fixed one more date of hearing.
- 8). The next date of hearing is fixed on 3rd June' 2025 (Tuesday) at 1100 hrs.

9). Take notice that in default of your appearance on the day of hearing mentioned above, the appeal will be heard and determined ex-parte and Section 20 (1) of the RTI Act, 2005 shall be invoked. The Appellant is also directed to be present during the hearing, failing which the case shall be disposed of without any further notice.
