## **SUMMON**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Karsang Tadu for non-furnishing of information by the PIO, o/o the Executive Engineer (PHE), Tali Sub-Division, Pip Sorang Block, District Kra Daadi, (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 07.02.2024.

This appeal is listed for hearing today on 01/11/24.

The Appellant Shri Karsang Tadu is present but the PIO, o/o the E.E (P.H.E), Tali Sub-Division Pip Sorang Block, District Kra Daadi (A.P) is absent.

On perusal of the WT message dated 08/10/24 forwarding the summon notice sent to the PIO o/o the E.E (P.H.E) Tali Sub-Division, Pip Sorang Block, it is found that the address of the Deputy Commissioner was wrongly mentioned as o/o the Deputy Commissioner, Yupia instead of D.C, Kra Daadi, Palin.

The E-mail was also wrongly sent to the D.C Yupia. The absence of PIO in the hearing is, probably, due to non-receipt of summon notice for hearing fixed on 01/11/24. Because of wrong address

In view of above the hearing of the appeal is adjourned to 22/11/24 which will be intimated to the PIO and Appellant in their actual and correct addresses.
