Order

WHEREAS, in connection with the **APIC-No. 131/2024**, the 2nd hearing held on 22nd August, 2024 related to the **APIC No-131/2024**. The Appellant Shri Takar Jamoh present during the hearing but the PIO found absent without intimating to the Commission the reason of his absence from the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the RTI, Act, 2005, which is a statutory duty binding upon the PIO.

The Appellant stated before the Commission that he has not been provided with the required information(s) as applied for and directed by this Commission in the first hearing of this appeal on dated 20.06.2024. Moreover, he has visited the office of the PIO multiple times but the PIO was not present in office as well as no one in the office of the PIO was instructed to provide the information(s) to him.

After hearing the Appellant, and going through the submission of the Appellant regarding not in receipt of the information(s) in full, the Commission ordered;

- (i) The PIO to furnish the written statement to the new appeal enjoined in the present appeal of the Appellant on or before next date of hearing.
- (ii) To **summon** to the PIO to appear before the Commission in person in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.**
- (iii) The next date of hearing has been intimated to the Appellant. No formal notice required to be issued.

The Commission ordered;

The next date of hearing is fixed on 1st October, 2024 at 2:30 PM (Afternoon)
