ORDER/SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri TamchiGungte, for denial of information by the PIO O/o the Executive Engineer (RWD), Likabali Division, Lower Siang District, Govt. of Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.04.2023.

In the hearing on 06.12.2024, the appellant was directed to go through the documents furnished by the o/o the PIO, o/o E.E (RWD), Likabali Division and report his satisfaction or otherwise within one week from 06.12.2024 so as to list the case for hearing, if required.

As directed, the appellant, vide his letter dt. 18.12.2024 addressed to the PIO, o/o E.E (RWD), Likabali Division, with copy endorsed to this Commission, had intimated that documents furnished to him during the hearing are incomplete and not as per his RTI application.

This Commission, considering the mandate of the RTI Act to furnish complete and satisfactory information to an RTI applicant, this appeal was listed for hearing on 29.01.2025 and summons were issued.

However, in today's hearing, no one appeared from the o/o the PIO despite summon notice.

The appellant was present who, reiterating his dissatisfaction as already communicated to the PIO vide his letter dt.18.12.2024, pleaded for direction to the PIO to furnish the documents in complete form as requested by him.

Since the PIO nor any of his representative is present, the hearing of this appeal is adjourned to 19.02.2025 and the PIO is directed to attend the hearing on that date with the left out/complete information without fail to avoid penal action under the relevant provisions of RTI Act, 2005.

Now, therefore, the PIO, O/o the EE (RWD), Likabali Division is hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the **19th February, 2025 (Wednesday) at 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense or online.

NOW THEREFORE, take notice that, in default of your appearance, on the day before mentioned, the matter will be heard and determined in your absence.
