SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Pisa Tapam, Village-Sate, P.O-Sarli, P.S-Koloriang, Kurung Kumey District, Arunachal Pradesh for non-furnishing of information by the PIO –cum-BDO, CD Block Sarli & Polosang, P.O/P.S-Koloriang, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 8th time today on 13th September, 2024.

The appellant Shri Pisa Tapom is present but the PIO, Shri John Deiru CO-cum-BDO, Sarli & Polosang CD block Dist. Kurung Kumey, AP is yet again absent despite summon notices.

Such continued absence of the PIO in the hearings except in one hearing (5th hearing) on 26-06-2024 has been viewed by this Commission as blatant and sheer disrespect to this Commission and the RTI regime.

The appellant submitted that as against 19 (nineteen) points, information as sought by him vide his application dated 04-07-2023, the information against 6 (six) points is yet to be furnished by the PIO.

The appellant further submitted that despite several requests and also as directed by this Commission, the PIO did not furnish the aforesaid remaining information.

From the non-response of the PIO, the Commission also feels that the PIO has not complied with the orders of this Commission deliberately which calls for action under the relevant provisions of the RTI Act, 2005 and accordingly, this Commission decides to issue show cause notice to the PIO as to why action under Section 20 of RTI Act, 2005 should not be initiated against him who shall submit his replies on or before 27th September and also appear in person in the Commission on that date.

Next date of hearing is fixed on 27th September, 2024 at 02.00 pm.


NOW THEREFORE, the PIO-cum-BDO CD Block Sarli & Polosang, Kurung Kumey District, AP is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the above date and time without fail.
