**Order**

**WHEREAS,** The 1<sup>st</sup> hearing held on 12<sup>th</sup> Nov'2024 related to the APIC No. 1170/2023(Appeal). The PIO present through online mode during the hearing but the Appellants Shri Riya Taram, Shri Takam Sakap & Shri Tap Sajan were found absent without intimating the reason to the Commission for their inability to attend the hearing..

**Heard the PIO:**

The PIO stated before the Commission that he has already intimated to the Appellants on dated 15/09/2023, for the fact that the information sought by them in their Form 'A' application are too voluminous to be provided in one go as well as ambiguous and not specific and spanning for 8yrs time w.e.f 2016 to 2024. The PIO stated before the Commission that the PIO, office is very busy in other public works and hence, they are not able to devote their time in only providing information(s) under RTI Act to the Activists for information(s) spanning too many years like 8(eight) years in this present case.

Therefore, the PIO had written to the Appellants to resubmit a fresh application for providing specific information to them on time, the information(s) that are not too voluminous, but till date the Appellants have not submitted a fresh application to the Appellants. Due to absence of the Appellant, the Commission could not proceed the hearing of this appeal.

**The Commission ordered;**

- (i) To issue summon notice to the Appellants to appear in person or through online mode before the Commission in the next date of hearing. **Failing which their appeal shall be decided as ex-parte.**
- (ii) Next date of hearing has been intimated to the PIO. No formal notice required to bge issued.

**The Commission ordered;**

**The next date of hearing is fixed on 16<sup>th</sup> Jan'2025 at 10.30.am ( Morning)**
