ORDER

The 1st hearing held on **6th February, 2025** related to the **APIC No-326/2024**. The Appellant Shri Tamchi Gunte is present during the hearing. The PIO is represented by APIO (Shri Tapi Mali) Assistant Engineer, PWD, Dirang Division, during the hearing before the Commission.

Heard the APIO:

The APIO stated before the Commission that all information(s) have been furnished to the Appellant.

- (iii) The Appellant to intimate the Commission about information receipt or not, on or before the next date of hearing.
- (iv) Formal notice need not be issued to the parties, as they are present during the hearing.
