The 1st hearing held on 7th Nov'2024 related to the **APIC No 709/2023.** The APIO is present during the hearing but the Appellant Shri Riya Taram, found absent without intimating the reason for his inability to attend the hearing.

Heard the APIO.

The APIO stated before the Commission that he has intimated to the Appellant that all the information are ready in his office and to collect the information from his office but the Appellant has not collected the information. The PIO even wrote a letter to the Appellant twice on **dated 17/7/2024 & 26/9/2024** to collect the documents from the PIO's office but Appellant has not turned up till date, to collect the information(s).

- (iii) To issue summon notice to the Appellant to be present in the next date of hearing in person or through online mode. Failing which his appeal shall be decided ex-parte.
- (iv) The next hearing is intimated to the PIO. No formal notice required to be issued.
