The 1<sup>st</sup> hearing held on 7<sup>th</sup> Nov'2024 related to the **APIC NO 709/2023**. The APIO is present during the hearing but the Appellant Shri Riya Taram, found absent without intimating the reason for his inability to attend the hearing.
