ORDER/SUMMON

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of 24 (twenty four) point information on Establishment of Integrated 10 bedded AYUSH Hospital at Ziro Lower Subansiri District under National AYUSH Mission during the financial year 2023-24 by the PIO, o/o the E.E (PWD), Ziro Division as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.10.24.

This appeal was heard on 18.07.2025 wherein the appellant, Shri Tamchi Gungte and Er. Shri Radha Monty, AE-cum-APIO were present.

This Commission, upon hearing the parties and considering the reasons for non-furnishing of the replies by the PIO, held then that the failure on the part of the PIO to furnish the requested information was, indeed, for genuine and justified reasons. However, since the PIO was mandated to furnish the documents to the appellant as requested by him which has been found not covered by any of the exemption clauses under section 8 of the RTI Act, 2005 this Commission had directed the PIO to furnish whatever documents are available in his office till now and also furnish declaration by way of affidavit against those which are not available within 1(one) month from the date of receipt of the order dt. 22.07.2025

The appellant has now, vide his letter dt. 22.08.2025 complained that the PIO, despite this Commission's order and his assurance, failed to provide the left out information and as such pleaded for taking penal action against the PIO.

In the premises above, this appeal is listed again on 10.09.2025 wherein the PIO shall appear with the left out information.

You are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC in person on the 10th September, 2025 (Wednesday) 10.30 am** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

NOW THEREFORE, take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard and determined in your absence.
