Heard the Appellant.

The Appellant stated before the Commission that the PIO has not furnished any of the information as sought by him in his form 'A' application till date.

After hearing the Appellant, the Commission viewed seriously on the absence of PIO and order ;

- To issue <u>summon</u> to the PIO to appear in person or through online mode before the Commission in the next date of hearing.
- (ii) The PIO to provide all the information(s) to the Appellant on or before next date of hearing as sought in his form 'A' Application. Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.

The Commission ordered;

The next date of hearing be fixed on 27th August, 2024 at 02:30 PM (Afternoon)

Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
