Summon Notice.

The 1st hearing held on **28th January, 2025** related to the **APIC-No-308/2024**. The Appellant Shri Nabam Nyajung, found absent without intimating the reason for his absence. The PIO-cum-BDO, CD Block, Balijan, Papumpare District, Govt. of Arunachal Pradesh, is present during the hearing before the Commission.

Heard the PIO:

The PIO stated that the information(s) sought by the Appellant under Form-A application are ready to be furnished to the Appellant, and therefore, he has written a letter to the Appellant on 25th day of November' 2024 to deposit the fees for the information(s) amounting to Rs. 87,450/- (Rupees Eighty Seven Thousand Four Hundred Fifty) only, if need in colour and Rs. 50,535/- (Rupees Fifty Thousand Five Hundred Thirty Five) only, if need in black and white for the information(s) running to 7,837 (Seven Thousand Eight Hundred Thirty Seven) pages, to which the Appellants have not yet replied to the office of the PIO.

The PIO further stated that without collecting the information(s) from the office of the PIO, the Appellants filed an Appeal at the First Appellate Authority (FAA), who is the Deputy Commissioner, Papumpare District. The First Appellate Authority (FAA) on 21.10.2024 served notice to the Appellants for hearing their Appeal on 29.10.2024, wherein both the Appellants failed to attend the hearing. That again the FAA on 8.11.2024 sent another notice for hearing the Appeal on 25.11.2024, yet again the Appellants did not turn-up on the date for hearing. Thereafter the Appellants have filed this Appeal in this Commission.

The Commission observed:

As the Appellants are absent further hearing could not be taken ahead and so this appeal is adjourned to a next date for hearing.

The Commission ordered:

- (i) Notice be issued to the Appellants to be present on the next date of hearing, failing which the appeal will be heard and decided ex-parte.
- (ii) Notice for the next date of hearing need not be issued to the PIO as he is present during the hearing.

The Commission ordered;

The next date of hearing be fixed on 1st April' 2025 at 2:30 PM (A/Noon)
