## ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri TamchiGungte, Near KV-II School Chimpu, PO/PS Chimpu, Itanagar, Papum Pare District, Arunachal Pradesh, for non-furnishing of information by the SPIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 08/05/2023 regarding the total list of project sanctioned under Pradhan Mantri Jan VikasKaryakaram (PMJVK), earstwhile - MsDP Scheme, Ministry of Minority Affairs Govt. of India during the financial year 2016-19.

The 3<sup>rd</sup> hearing is held on 30<sup>th</sup> April, 2024 as scheduled. Shri C.J. Monnou, the PIOcum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh is represented by Adv. Y. Chipui. The Appellant Shri Tamchi Gungte is present. The representative of the PIO brought two sets of document and furnished one set to the Appellant claiming to be the information sought by the Appellant. The Appellant after going through the document informed that the information so furnished are not authenticated.

The Commission has directed the representative of the PIO to authenticate the documents and furnish to the Appellant in the next date of hearing. The Appellant is directed to take the one set of copy and verify if there is any shortage in the information as sought by him. If any information not furnished by the PIO, the Appellant is directed to intimate to the PIO with a copy to the Commission within ten days from the date of issue of this order and get complete information before the next date of hearing. The PIO was served with Show Cause Notice on the 2<sup>nd</sup> hearing held on 27<sup>th</sup> February, 2023, which he has not submitted. It is regretted and viewed seriously by the Commission for non compliance of the directions by the Commission.

Both the parties are directed to appear before the Commission's court on the next date of hearing without fail. If the SPIO is found absent the Commission may initiate penal provision under section 20(1) of the RTI Act 2005 and in case Appellant is found absent the case shall be disposed of without any further notice, presuming that the Appellant is no more interested in the information.

The next date of hearing is fixed on 2<sup>nd</sup> July, 2024 (Tuesday) at 1030 hrs.

Therefore, Shri C.J. Monnou, the PIO-cum- EE(WRD) Govt. of A.P., WRD Namsai Division, Namsai District, Arunachal Pradesh is hereby summoned to appear before this Court in person on the scheduled date and time without fail.
