ORDER

The 2nd held on 21st November 2024, related to the APIC No-226/2024. The Appellant Shri Tai David and the representative of PIO present during the hearing.

Heard both the parties.

The Appellant stated before the Commission that he has received the information(s) requested in serial no. 9 which is utilization certificate and information(s) listed in other serial no. of his application have not been provided till date.

The representative of the PIO stated that the information(s) which are not furnished to the Appellant are with other eleven (11) Divisions/Competent Authority, to provide the full information to the Appellant he has already written and forwarded letter to those eleven concerned Executive Engineers /Division/Competent Authority to provide the full information to the Appellant, but till date no response have been received from the said Divisions. The PIO stated that SI No. (1& 5) are voluminous and cover about 200 pages and there are 91 DPR covering 91 villages and so the, PIO sought permission to the Commission to give him time for two months for preparation of documents.

After hearing both the parties and going through the form 'A' application, the Commission ordered;

- (i) The PIO to write a reminder letter to all the eleven (11) Divisions/ concerned executive Engineers and Competent Authority to provide all the information(s) on or before next date of hearing to the Appellant. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.***
- (ii) The instant PIO to provide the information(s) pertaining to serial no. 2,3,4,6,8 & 9, as cited in the Appellants application and information pertaining to serial no. 7 & 10 are exempted and only those firms names where transaction was done be provided along with name of the beneficiaries and total amount of money paid to them on or before next date of hearing. ***Failing which action 25(5) shall be initiated against the PIO as per the provisions of RTI Act, 2005.***

- (iii) The Appellant to communicate/follow up or intimate the concerned Executive Engineers Competent Authorities/11 Divisions to provide him the information(s) as per the letter forwarded by the instant PIO.
- (iv) Next date of hearing has been intimated to the both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 30th January' 2025 at 10:30 AM (Morning)
