WHEREAS, in connection with the **APIC-No. 185/2024**, your personal appearance is required before the Commission on **05th September 2024 at 10:30 AM** The PIO present during the hearing but the Appellant Shri Lokam Namdu found absent consecutively for two times without intimating to the Commission the reason for his absence during the hearing.
