WHEREAS, in connection with the <u>APIC-No. 185/2024</u>, your personal appearance is required before the Commission on 05th September 2024 at 10:30 AM The PIO present during the hearing but the Appellant Shri Lokam Namdu found absent consecutively for two times without intimating to the Commission the reason for his absence during the hearing.

WHEREAS, the PIO stated before the Commission that as per the order passed in the last hearing on dated 06/06/2024 the PIO has compiled all the information(s) to be provided to the Appellant and also, the PIO has informed the Appellant to collect the said information(s) from the office of the PIO. But the Appellant till date did not turn up to collect the information(s).
