WARNING SUMMON

WHEREAS, in connection with the **APIC-No. 346/2024**, your personal appearance is required before the Commission on **4th December, 2025 at 10:30 AM**. The 3rd hearing held on **26th August' 2025**, related to the **APIC No. 346/2025 (Appeal)**. The Appellant Shri Riya Taram, is found absent during the hearing. The PIO -cum EE (PWD) is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

During the last hearing PIO had requested the Commission to give him some more time to trace out the form 'A' application of the Appellant as he has taken charge as the PIO in the month of December 2024. And the first hearing was held on 28/01/2025

Wherein he came to know of this appeal and after that hearing the financial year end process started and his officers being busy in delivering other public services till this time as the financial year end has certain strict rules to be followed and adhere to. The office of the PIO could not compile the information sought by the Appellant to be furnished to the Appellant. But this time both the parties are absent and therefore the Commissioner could not proceed the hearing of the appeal.

The Commission seriously viewed the absence of both the parties.

The Commission hereby orders;

- i) **To issue warning summons** to PIO, to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action will be initiated against the PIO as per the provisions of RTI Act 2005.**
- ii) **To issue warning summons** to the Appellant to appear before the Commission in person or through online mode in the next date of hearing. **Failing which their appeal shall be heard and determined ex-parte.**
- iii) The next date of hearing has been intimated to the both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 4th Dec 2025 at 10:30 AM(Morning).
