SUMMON

WHEREAS, in connection with the **APIC-No. 333/2024**, your personal appearance is required before the Commission on **22nd July, 2025 at 02:30 PM**. The 1st hearing held on 24th April 2025, related to the APIC No-334/2024. The Appellant Shri Nibo Pao, found absent during the hearing and PIO-cum DFO Tezu Forest Division, is also absent during the hearing without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that the PIO besides, public duties also has to attend Court hearing when an appeal is preferred against him as per the provisions of the RTI Act 2005, which is a statutory duty binding upon the PIO.

The Commission seriously viewed the absence of both the parties and hereby orders;

- (i) To **issue summon** to the PIO to appear in person or through online mode before the Commission in the next date of hearing. **Failing which necessary action shall be initiated against the PIO as per RTI Act 2005.**
- (ii) To **issue summon** to the Appellant to appear in person or through online mode before the Commission in the next date of hearing. **Failing which his appeal shall be decided ex-parte.**

Due to absence of the both the parties, the Commission could not proceed the hearing of the appeal.

The Commission ordered;

The next date of hearing be fixed on 22nd July 2025 at 2:30 PM
