**SUMMON**

**WHEREAS**, in connection with the **APIC-No. 140/2025**, your personal appearance is required before the Commission on **13 November, 2025 at 10:30 AM**. The 1<sup>st</sup> hearing held on **5<sup>th</sup> August, 2025**. The Appellant Miss Bengia Mama is present.

1. To send Summons to the PIO-cum-DDSE Daporijo, Upper Subansiri District to be present in the next date of hearing without fail, failing which necessary action will be initiated against the PIO as per the provisions of RTI, Act, 2005.
2. The Appellant to be present in person or through online mode in the next date of hearing, failing which this instant appeal will be heard and determined ex-parte.
3. Notice need not be issued to the Appellant as she is present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 13<sup>th</sup> November, 2025' at 10:30 AM (Morning).
