ORDER

Whereas the 1st hearing held on **16th May, 2024** related to the **APIC No-134/2024**. The Appellant Shri Takar Jamoh & the representative of the PIO Shri Vibhanshu Goswami, Manager (Law) were present during the hearing.

Heard both the parties.

After hearing the parties and going through the Form 'A' application of the applicant, the Commission directed the PIO to furnish the information as applied in serial no. 2 of the form 'A' as per the provisions of section 8 (2) sub - section 1 of the RTI Act, 2005 which says, "a public authority may allow access to information, if public interest in disclosure outweighs the harm to the protected interests.

In the instant appeal it is made known before the Commission that there have been many applicants for the Retail outlet on the specified location. The right to crosscheck the veracity of the qualifying documents of the selected candidates by the other candidates that had participated for the same Retail outlet cannot be denied and hence, the information be furnished to the Appellant.

Regarding the rest information sought, the Appellant has stated himself that they are not anymore needed by him and so, need not be furnished save, the information sought in serial no. 2 as applied in Form 'A' by the Appellant

The Commission directed the representative of the PIO to furnish the particular information to the Appellant on or before next date of hearing.

The next date for hearing has been intimated to both the parties. No formal notice required to be issued.

The next date for hearing is fixed on 27th June, 2024 at 10:30 am (Morning)
