Summon Notice.

The 1st hearing held on **12th November, 2024** related to the **APIC-No-946/2023**. The PIO is present through online mode. The Appellants Shri Riya Taram and others found absent during the hearing without intimation to the Commission for their inability to attend the hearing.

Heard the PIO:

The PIO informed the Commission that the information(s) sought are too voluminous and lengthy to be provided as the information(s) sought for, are spanning to 7 (Seven) years. However, the PIO had already intimated the Appellants through a letter on 24.08.2024 to collect the information(s) by paying an amount of Rs. 11,210/- (Rupees Eleven Thousand Two Hundred Ten only) as the fee for the information(s) sought. But the Appellants have not yet, turned up to collect the information(s) readied by the PIO, till date.

After Hearing the PIO and going through the Form A application of the Appellants, the Commission ordered;

- (i) ***The Appellant to pay the requisite fee amounting to Rs. 11,210/- (Rupees Eleven Thousand Two Hundred Ten only) and collect the information(s) sought from the Office of the PIO and inform the Commission about the receipt of complete or incomplete information(s) on or before the next date of hearing.***
- (ii) ***To issue summon to the Appellants to appear in person or through online mode in the next date of hearing. Failing which their appeal shall be decided ex-parte.***
- (iii) Next date of hearing has been intimated to the PIO. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 16th January' 2025 at 10:30 AM (Morning)
