This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of below mentioned information by the PIO, o/o the Executive Engineer (PHED), Khonsa Division, Dist.: Tirap, 792103, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 04.09.2024.

A) Particular of information: C/o "Integrated Drinking Water Project through hybrid of lift and Gravity distribution system with value addition of Tourism components at Deomali in Tirap District, under the North east Special Infrastructure Development Scheme (NESIDS) in Arunachal Pradesh during the financial year 2022-23.

- 11. The certified copy of contractor enlistment update reports, of tender winning firm;
- 12. The certified affidavit copy sworn before a competent magistrate to the effect that he/she does not have 2 (two) or more incomplete ongoing commitment (Project/contract to execute) at the time of bidding by the tender participant and winning firm. (as per rule SPWD/W-66/2012 Dtd. 01-08-2018) and
- 13. The certified copy of declaration letter from the contractor (if the tender participant is from different state) to the effect that he/she has not been debarred from tendering by authority in which contractor is registered {As per CPWD Works Manual 2014, Section 15.2.3(2)}.
