SUMMON NOTICE

WHEREAS, in connection with the APIC-No.352/2024, your personal appearance is required before the Commission on **1st April, 2025 at 02:30 PM**. The **1st hearing held on 28th January, 2025** related to the APIC-No-352/2024. The Appellant Shri Taguk Dada is absent. Heard the representative of the PIO:

- (ii) Notice for the next date of hearing need not be issued to the PIO as his representative is present during the hearing.
- (iii) Notice be issued to the Appellant to be present personally or through online mode on the next date of hearing, failing which the Appeal will be heard and decided ex-parte.

The Commission ordered:

The next date of hearing be fixed on 1st April' 2025 at 2:30 PM (A/Noon).
