ORDER

This is an appeal filed under sub-section (3) of the Section 19 of the RTI Act, 2005. Brief fact of the case is that the appellant Shri Tajum Dadi on 13.12.2022 filed an RTI application in Form-A to PIO cum DPO O/o the Deputy Commissioner Daporijo Upper Subansiri District AP, whereby, seeking various information as quoted in Form-A application.

Appellant being not received information from the PIO, filed the First Appeal before the First Appellate Authority cum DC Daporijo, Upper Subansiri District AP on 03.03.2023

Appellant again having not received the required information and decision from FAA, filed the Second Appeal before the Arunachal Pradesh Information Commission on 06.04.2023.

The Registry of the Commission (APIC), on receipt of the appeal, registered it as APIC-No.289/2023 (appeal) and processed the same for its hearing and disposal.

Accordingly, this matter came up for 7<sup>th</sup> hearing before the Commission Court today on 05.09.2024. Notice of hearing dated 13.8.2024 were served to PIO and the Appellant.

In this hearing of the appeal on 05.09.2024 the respondent PIO Shri Tapak Rakmi DPO O/o the Deputy Commissioner Daporijo is present. The appellant himself is absent but represented by Shri Karnium Gumsar Tamin with written authorisation from the appellant.

Heard the parties present.

The representative of the appellant states that he has come to court to represent the appellant but he is not aware as to whether the appellant and the PIO has complied this commission court order of 6<sup>th</sup> hearing dated 10.06.2024. While hearing proceeding was on, the representative of the appellant casually tries to make telephone call from the commission court to appellant to know about the case. In the written authorisation letter for representation, the appellant submits that the PIO should remit the penalty imposed on him under Section 20(1) of RTI Act 2005 and pay compensation to him.

PIO submits that appellant has visited ADC / PIO office but refused to receive the information documents stating that the information should be brought to commission court. So, he has come with information document. The representative of the appellant has received the information documents in the Commission court today.

After hearing both the parties it is hereby ordered that the appellant shall examine the information documents furnished to him and if there is any shortfall within the purview of the content in the original RTI application in form-A, shall file written submission to the PIO with distinct and specific mention of the shortfall within a period of two weeks from the date of issue of this order and obtain written acknowledgement. The appellant shall submit such written submission, if any, to this commission with copy of acknowledgement obtained. If such report is not received in the commission, it will be presumed that the information furnished is correct and to the satisfaction of the appellant.

The hearing is adjourned. Next date of hearing shall be fixed in due course of time after receipt of compliance report from PIO and appellant.
