**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte, for non-furnishing of information by the PIO O/o the Executive Engineer, RWD Dept. Aalo, West Siang District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 4<sup>th</sup> time today on 20/09/24 wherein the Appellant Shri Tamchi Gungte is present and the APIO, Shri Mojum Kamki o/o the E.E (RWD) Aalo Division West Siang District attended the hearing through Video Conference (V.C).

The Appellant submitted that he has received the documents on 18/09/24 but he is not satisfied with the documents as the documents are not arranged properly and not certified.

When queried, the APIO stated that the information(s) are being furnished to the Appellant in the form they were received from the Likabali Division.

The Appellant submitted that the PIO be directed to furnish the information as per his application and with proper arrangement and annexure number.

The Commission also found that the information received by the PIO are not properly arranged and indexed.

As such the PIO/APIO is directed to provide the information in proper arrangements and also directed that the PIO shall attend the next hearing personally without fail.
