This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram & 3 others for non-furnishing of below mentioned information by the PIO o/o the Block Development Officer, CD Block, Nyapin, Kurung Kumey District, Govt. of Arunachal Pradesh, as sought for by them under section 6(1) (Form-A) of RTI Act, 2005 vide their application dated 20.01.2025.

- Give the Technical/Sanction order/Work Order copy/first & final bill/Billing voucher/LOC copy with details of payment like Xerox copy of Cheque leaf/demand draft/banker cheque/pay In slip for NEFT/RTGS/deposit Treasury Challan as per name of work order wise.
- Give the Name of Contractor/Agency with their bank account number against above Specified Name of Scheme list wise.
- 3. Give Coloring Photocopy of Geo-tag Report/CIB is mandatory of above mentioned work wise.
- 4. Give the Money Receipt List of Contractor bill Payment with their name & contact number.
- 5. Give the Xerox copy of Name of Agency with contact number of Proprietor.

- 6. Give the details of billing Sheets/scheme Sheets copy of Specified work wise.
- 7. Give the MB records/Cashbook Statement from 2022-2023.
- 8. How many amount has been deducted from contractor bill payment against above mentioned Schemes as percentage as. per the Govt. guidelines. For example GST=%,DC =%, ADC=%, PD =%, BDO=%, Apo(RE)=%, Block JE/PTA=%, Director RD =%, ZPC =% etc. Please Give the various name of deduction.
- 9. Give the Certified Coloring Photocopy of all the work Sites by BDO Nyapin.
- 10. Give the Coloring photocopy/videography of every work site which might be before starting of work/Starting of work and ending of work.
- 11. Give the NOC copy of ZPC/ZPM/GPC/Gaon buras/Gaon buris of concern village/block.
- 12. Give Name of Officers & Officials with their Signature/Seal, Who hold the DDO Power to approved the financial matter or carried out the Works.
- 13. Give details of Enlistment of contractor as per work department Rules Act 2008.
- 14. Give details of proprietor of firm/Registration of certificate.
- 15. Give the Money deposited Challan of Govt. account against GST/Royalty by department/firm in work wise.
- 16. All the bill Payment must be Paid to the Contractor Accurately as per amount which mentioned in the Sanctioned Order/Name of Scheme list. ALL the document must be provide in CTC by Concern Pio.

Period from which information asked for: 2022-2023.

Records in the appeal reveal that the appellants had requested the PIO for the aforementioned information but failed to obtain the same within the statutory period of one month which prompted them to file appeal before the First Appellate Authority (FAA), the Deputy Commissioner, Koloriang, Kurung Kumey District, Govt. of A.P. under section 19(1) of the RTI Act vide their Memo of Appeal dt. 21.02.2025. But having failed yet again to obtain the information, they preferred second appeal before this Commission under section 19(3) of the RTI Act vide Appeal Memo dt.21.03.2025.

This appeal is, accordingly, listed today on 23.07.2025. But the appellants are absent, though one of them, namely, Shri Riya Taram has sent a message through whatsapp saying that due to health issue he will not be able to attend the hearing.

The PIO, Shri Tame Naya, BDO, CD- Block Nyapin who appeared in person brought in the requested documents (for the year 2022-23) vide forwarding letter dt.20.07.2025 a copy whereof has been retained in this Commission. As the appellants were absent, the documents could not be handed over to them and their response thereto could not be obtained.

In the premises above, this appeal is listed again on 29th August, 2025.

NOW THEREFORE, you are hereby summoned to appear in person or online in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC on the 29th August, 2025 (Friday) at 2 pm to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.

Take notice that, in default of your appearance, on the day above-mentioned, the matter will be heard and determined in your absence.
