This is a Complaint under Section 18(1) of RTI Act, 2005 received from Shri Bengia Jayanta for denial of information by the PIO, o/o Director, (Panchayati Raj), Govt. of A.P Itanagar, A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 27.09.2024.

This complaint was heard on 29.11.2024 and this Commission, after explaining to the complainant the implication of the provisions of the two sections viz, section 18 and section 19 of the RTI Act, 2005, converted the complaint into appeal under section 19(3) and accordingly, directed the PIO to furnish the information sought for by the applicant/complainant vide his application dt.27.09.2024 on or before the next date of hearing on 10.01.2025 and the complainant / appellant was also directed to submit the copy of his said application to the PIO within a week from 29.11.2024.

However, both the parties are absent today.

The hearing is, therefore adjourned to 31.01.2025 wherein, if the appellant fails to appear, the appeal shall be disposed off and closed as not being pressed further by the appellant.
