**ORDER/SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Smt. Bengia Rina & Shri Bengia Tani for non-furnishing of 16(sixteen) point information regarding the c/o Community Hall at new Bazar, Koloria ng by the PIO, o/o the Executive Engineer (PWD), Sangram Division, Kurung Kumey District (A.P) as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide his application dated 18.10.2024.

**Hearing and decision:**

This appeal was, accordingly, listed and heard on 11<sup>th</sup> June, 2025 wherein the Appellants were absent but Shri Bini Tare, PA attended the hearing in person on behalf of the PIO.

Since the appellants were absent, this Commission could not get the confirmation from the appellants as to whether or not they have received the requested documents from the PIO in terms of the order passed by the FAA.

The hearing of this appeal was, thus, adjourned to today on 16<sup>th</sup> July, 2025 wherein Shri Bini Tare, the representative of the PIO was present in person and one of the appellants Shri Bengia Tani appeared through VC.

Heard the parties.

The appellant reiterated his demand for the requested information.

The representative of the PIO brought in some documents but on perusal it was found that the documents were related to some other RTI application.

This Commission, therefore, adjourns the hearing to 01.08.2025 and directs the representative of the PIO to furnish the requested documents in complete and satisfactory form to the appellant within 15 days from the date of receipt of this order and report compliance thereof in the hearing on 01.08.2025. The appellants is also directed to collect the documents from the o/o the PIO and intimate the receipt thereof and also attend the hearing on **in person** failing which this appeal shall be disposed of and closed presuming that they are satisfied with the documents.

**NOW THEREFORE**, you are hereby summoned to appear in person in the Hon'ble Court of Shri Sangyal Tsering Bappu, **SIC on the 1<sup>st</sup> August, 2025 (Friday) at 2 pm** to answer the claims, and you are directed to produce on that day all the documents upon which you intend to rely in support of your claims/defense.


Take notice that, in default of your appearance, on the day above- mentioned, the matter will be heard, determined in your absence and closed.
