The 3<sup>rd</sup> hearing was held on **28/10/2024** related to **APIC NO-1156/2023 (Appeal)**. Both the parties appellant Shri Tadar Chai and PIO-Cum-Divisional Forest Officer, Koloriang found absent during the hearing without any information to the Commission.

In the last hearing PIO-Cum-DFO, Forest Division, Koloriang has stated before the Commission that he is newly posted as DFO Koloriang. The PIO-Cum-DFO stated that there is only 1 (one) RFO in the Divisional Forest Office, Koloriang, so it is very difficult to furnish the information at the time. Moreover, the information sought in his RTI Application is of voluminous and the period from 2012-2022. The appellant is requested to curtail the time period and seek for one scheme per year. The appellant has agreed to the request made by the PIO and has sought information for the one year period from 2022-2023.

Last chance is given to PIO, to furnish the information as sought by the appellant on or before the next date of hearing on 18/10/2024.

The Commission directed both the parties to be present in person before the Commission in next date of hearing. Failing which necessary action shall be initiated as per the RTI Act, 2005.

Commission adjourned the hearing and fixed next date of hearing on 18/11/2024 at 1030 hours.
