**The 9<sup>th</sup> hearing was held on 30<sup>th</sup> October, 2024** related to **APIC NO-504/2023(Appeal)**. Both the parties appellant Shri Palen Laa and PIO-cum-DPO, Raga found absent during the hearing without any information to the Commission.

During the 8<sup>th</sup> hearing on 18<sup>th</sup> September, 2024 the representative of PIO Shri Giper Bini UDC-cum-Accountant brought the documents as sought by appellant before the Commission and handed over to the appellant. If, he is absent in the next hearing the Commission will deem that he is satisfied by the information provided to him and accordingly the case will be decided ex-parte in his absence.

The Commission adjourned the hearing and fixed next date of hearing on **20<sup>th</sup> November, 2024 at 2 PM**.
