SUMMON ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received **Shri Bengia Raju, G-sector, Ward no.26, PO/PS-Naharlagun, Arunachal Pradesh** for non-furnishing of information by the **PIO-cum-EE, PWD Sangram Division, Kurung Kumey Dist., Govt. of Arunachal Pradesh** as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The last hearing of this case was heard on 7th June,2024. The appellant was present and the representative of the PIO Shri Bini Tare, PA-cum- In-charge RTI Cell was also present. Heard both the parties. The representative of the PIO has furnished the information(s) as sought for by the Appellant during the hearing of this case. On examination of the documents by the Commission it was found that some portions of information are to be provided by the PIO in the scheme namely Improvement of District township Road at Koloriang such as Justified Sheet, Comparative Statement, Bank Guarantee Copy and Bill payment and the rest information(s) as provided is satisfied according to the Appellant. Further, the Appellant has requested for site inspection of both the Schemes/Projects. So, the site inspection be done as soon as possible and submit the report to the Commission by both the parties on or before the next date of hearing of this case along with the left out information(s) as sought for by the Appellant.
