<u>ORDER</u>

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Prades 1 for non-furnishing of information by the PIO, o/o the BDO, Damin, CD Blocks, Kururg Kumey District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

In the interim order dated 03/07/24 wherein both the parties were absent, this commission made the four BDOs of Parsi Parlo, Damin and Sarli, as the PIOs of respective offices for the purpose of consideration of the appeal nos. 337, 338 and 339 respectively and accordingly, issued Summon notices to the aforesaid four BDOs to attend the hearing on 09/08/24.

But, except the BDO of Parsi Parlo, the other 2 (two) BDOs did not attend the hearing.

The Appellant who attended the hearing informed the Commission that the BDO, Damin has intimated his inability to attend the hearing.

The Appellant, however, informed that he has received some information(s) from the BDO, Damin a few days back which he will go through and report his satisfaction/otherwise within two weeks.

As requested by the Appellant, he is directed to go through the information(s) and report his satisfaction/otherwise within two weeks whereafter the next date of hearing, if required, shall be fixed and summons will be issued accordingly.
