This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Riya Taram for non-furnishing of information by the PIO, o/o the Executive Engineer RWD, Tezu Division, Lohit District, Arunachal Pradesh as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide application dated 15.05.2023

This appeal is heard for the 2nd time today on 30th October, 2024 as scheduled wherein the Appellant Shri Riya Taram was present and Ms. Khyoda Mema, APIO, o/o the E.E (RWD), Tezu Division was also present.
