SUMMON

The 4th hearing held on <u>3rd July, 2025'</u> related to the <u>APIC No-1150/2023</u>. The Appellant Shri Tania June is absent. The PIO of the office of the Chief Engineer, PHE Department, Eastern Zone, Itanagar, Papumpare District, Govt. of Arunachal Pradesh, found absent for the consecutive foru times during the hearing without intimating to the Commission, the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO also has a mandatory duty to attend to statutory duties besides public duties, when an appeal is preferred against him/her.

Due to non presence of both the parties the appeal is posted to another date.

Taking serious note of the absence of the PIO for the fourth consecutive times despite summon being issued to him;

The Commission hereby orders as follows;

- To issue bailable warrant of arrest to the PIO of the office of the Chief Engineer, (i) PHE, Department, Eastern Zone, Itanagar, Papumpare District, Govt. of Arunachal Pradesh, for securing his attendance in the Fifth Hearing of this appeal.
- To issue notice to the Officer-In-Charge, Itanagar Police Station for executing the (ii) bailable warrant of arrest and to return the same on the next date of hearing of this appeal which is fixed on 07.10.5025, 2:30 PM.
- Order for the bailable warrant of arrest be informed to the Deputy Commissioner, (iii) (ICR) Papumpare District and the Superintendent of Police, (ICR) Papumpare District for compliance of the same.
- The PIO to provide all the information(s) to the Appellant which are available in (iv) the office of the PIO on or before the next date of hearing.

The Commission hereby orders;

The next date of hearing be fixed on 7th October, 2025' at 2:30 PM (Evening)
