SUMMONS

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Tamchi Gungte for non-furnishing of information by the PIO, o/o the Project Director, DRDA, Koloriang Kurung Kumey District Govt. of A.P as sought for by him under section 6(1) (Form-A) of RTI Act, 2005 vide application dated 01.05.2023.

This appeal is heard for the 4th time today on 6th November, 2024 wherein the Appellant Shri Tamchi Gungte is present but the PIO o/o the PD, DRDA, Koloriang, Kurung Kumey District, A.P. is again absent.

In the last hearing on 09/10/2024, the PIO was absent reportedly due to health problems, but in today's hearing he is absent without any intimation nor did he depute any representative which has been viewed seriously by this Commission and therefore, directs the PIO to attend the next date of hearing in person or depute some one with the sought for information failing which he shall be issued show cause notice under Section 19(8)(b)-(c) read with section 20 of the RTI Act 2005 for disrespecting this Commission and violating the provisions of the RTI Act. 2005.

The next date of hearing of this appeal is fixed on 27th November, 2024 at 10.30 am.
