SUMMON ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Bamang Pacho, Forest Park, Near Main Powerhouse, House No. IMC-491, W-10, Itanagar, Arunachal Pradesh for non-furnishing of information by the PIO – cum-BDO Parsi Parlo CD Block, Kurung Kumey District, Govt. of Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

The last hearing of this case was held on **12/06/2024**. The Appellant was present but the PIO was absent. During the hearing of this case, it was found that the sought for information by Appellant is not under the custody of the present PIO i.e PD DRDA Koloriang, but, with the concerned BDOs of Kurung Kumey District. Hence, the respective BDOs of Kurung Kumey District are required to be made the necessary parties of this case and therefore the BDOs of Parsi Parlo, Damin, Sarli and Koloriang CD Block are required to be summoned to appear with the information(s) sought for by the Appellant in the next date of hearing of this case.
