SUMMONS

Whereas a show cause notice dt.16.09.2024 was issued to Shri John Diru, CO-cum-BDO and the PIO o/o BDO, Sarli & Polosang CD Block, Kurung Kumey District, Arunachal Pradesh under Section 19(8)(b) & (c) r/w section 20 of the RTI Act, 2005 for violation of the provisions of section 7(1) of the RTI Act 2005.

2. And whereas the show cause was heard on 27.09.2024 and as directed the PIO attended the hearing along with the remaining information and in course of hearing the PIO submitted that he could not attend the last hearing due to his pre-occupation in an important administrative works relating to the department of Art & Culture of which he is also in charge. The PIO also submitted a written explanation in this regard.

4. And whereas this Commission considered the explanation advanced by the PIO and was satisfied with the same. Further, the Commission considered the fact that Applicant/Appellant who was handed over the remaining information brought in by the PIO was also convinced of the reasons of the PIO's absence in the last hearings.

5. And whereas in view of the fact that the PIO has brought in and furnished the left out information to the Applicant/Appellant, this Commission found that no action under the provisions of section 20 of the RTI Act is warranted against the PIO and accordingly, the show cause notice dt.16.09.2024 issued to the PIO was disposed of and closed with the direction to the Applicant/Appellant to go through the left out information he received from the PIO and report his satisfaction or otherwise to this Commission within 2(two) weeks from 27.09.2024 so as to schedule the date for next hearing, if required.

6. And whereas, the applicant/appellant, vide his letter dt.14.10.2024, informed the Commission that he had gone through the documents furnished by the PIO and found that the PIO has not furnished the main document i.e the Social Audit Report of the work under MGNREGA and requested this Commission to hear the appeal again and fix suitable date therefor.

7. This Commission considered the request of the applicant/appellant and decides to hear the appeal again and accordingly fix the date of hearing on 08.11.2024.

NOW THEREFORE, the PIO-cum-BDO CD Block Sarli &Polosang, Kurung Kumey District, AP is hereby summoned to appear in the Hon'ble Court of Shri Sangyal Tsering Bappu, SIC in person on the above date and time without fail.
