**Summon Notice.**

The 2<sup>nd</sup> hearing held on 14<sup>th</sup> Nov, 2024 related to the APIC No-205/2024. The Appellant Shri Nabam Tai present during the hearing but the PIO found absent consecutively two times without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the **RTI, Act, 2005**, which is a statutory duty binding upon the PIO.

Heard the Appellant.

The Appellant stated before the Commission that till date no any information(s) has been received from the PIO, even after the Commission ordered. The PIO to provide the information (s) to the Appellant.

Due to absence of the PIO, the Commission could not proceed the hearing of the appeal.

The Commission after going through the previous ordered passed by this Court in last two previous hearing observed;

(i) Under the provisions of section 25(5), the Secretary/PCCF, Department of Forest and Environment, Govt. of Arunachal Pradesh, to initiate action to ensure the attendance of the PIO in the instant appeal, without fail. The Secretary /PCCF Department Forest & Environment to sent a copy of the action taken, to this Commissioner for record, **failing which necessary action shall be initiated as per the provisions of RTI Act.2005.**

(i) To **summon** the PIO to appear in person or through online mode before the Commission in the next date of hearing.

- (ii) The PIO to furnish all the information(s) to the Appellant as applied in his form 'A' application on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of the RTI Act,2005.***
- (iii) Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
- (iv) The Court ordered;
