ORDER

The 2nd hearing held on **21st November, 2024**, related to the **APIC No-227/2024**. The Appellant Shri Tai David and the representative of PIO Shri Hilang Kaya, JE present during the hearing.

Heard both the parties.

The Appellant stated before the Commission that he has not received any of the information(s) from the PIO till date.

The PIO stated that information(s) are very voluminous as sought by the Appellant in his application. The representative of PIO requested the Commission as well as the Appellant to give him some time to prepare the said information(s) and requested the Appellant to specify the information(s) which he would prefer to be given on priority amongst the information(s) as applied by him. The serial no. 1,2,3,7 & 8 are ready in soft copy. The information sought pertaining to serial no. 4, 5, 6 & 9 are not available with the PIO's office.

After hearing both the parties and going through the form 'A' application, the Commission ordered;

- (i) The PIO to give reason in writing as to why they cannot provide the information(s) to the Appellant pertaining to serial no. **(4,5,6 & 9)** on or before next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.***
- (ii) The Appellant to inform the Commission whether the information (s) provided to him by the PIO, in electronic form are complete or incomplete information as applied, on or before the next date of hearing.
- (iii) Next date of hearing has been intimated to both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 30th January 2025, 10:30 AM (Morning)
