**ORDER**

The 3<sup>rd</sup> hearing held on 30<sup>th</sup> January 2025, related to the APIC No-226/2024. The Appellant Shri Tai David and PIO present during the hearing.

**Heard both the parties.**

The Appellant stated before the Commission that he has received the information(s) partially only from **Lhau - I & II** Division and informations from rest divisions are not provided to him till date.

The PIO stated before the Commission that he has written letters to all the concerned Divisions with whom the information(s) are kept to furnish required information(s) to the Office of the PIO or to the Appellant but they have not responded till now.

The Commission observed that despite the direction given to the PIO, during the last hearing to write letters to the concerned divisional PIOs and to furnish the required information as per the RTI application, the same has not been complied with till date. The PIO appears to be negligent and careless in this regard. Further, where the work has been executed through quotations or work orders instead of inviting tender, the detailed information and committee report must be provided to the Appellant.

PIO is also to provide form 'A' application of the Appellant to all the concern divisions as per provisions of section 6(3) (ii) and inform them all to attend the next hearing. **Failing which necessary action will be initiated against all the PIO's as per the provisions of RTI Act 2005.**

After hearing both the parties and going through the form 'A' application the Commission order;

- (i) The PIO to provide the information(s) pertaining to serial no. **2,3,4,6,8 & 9**, as cited in the Appellants application and information pertaining to serial no. 7 & 10 are exempted and only those firms names where transaction was done be provided along with name of the beneficiaries and total amount of money paid to them on or before next date of hearing. ***Failing which action under section 25(5) shall be initiated against the PIO as per the provisions of RTI Act, 2005. And PIO to send letters again to concern Division along with the attested form 'A' application of the Appellant.***

- (ii) The Appellant to communicate/follow up or intimate the concerned Executive Engineers/ Competent Authorities of respective Divisions to provide him the information(s) as per the letter forwarded by the instant PIO.
- (iii) Next date of hearing has been intimated to both the parties. No formal notice required to be issued.

**The Commission ordered;**

**The next date of hearing be fixed on 3<sup>rd</sup> April 2025 at 10:30 AM (Morning).**
