- 6. Furnish the Tender Evaluation Copy along with the list of Firms participated in the tender processed for the work.
- 7. Furnish the Name of firm who won the tender work with respect to the subject mention above.
- 8. Furnish the certified Copy on which Date the project has been started.
- 9. Furnish the Certified Copy of Completion Certificate for the Subject mention above.
- 10. Furnish the certified Payment Details made through PFMS under DBT only, with respect to the subject mentioned above.
- 11. Furnish the Geo Coordinate information for the work mentioned above.
- 12. Furnished the certified Photograph of Worksite (glossy paper) before starting of work and after completion of work.
- 13. Furnish the name of Officers and their Designation at the time of monitoring the work.
- 14. Furnish the certified Full agreement Copy made in between the executing agency and the firm owner.
- 15. Furnish the Certified copy of Contractor Registration, Trading License, GST No., and GST Return 3B filled for previous Tax period.
- 16. Furnish the Certified copy of Contractor Enlistment Update Reports, T&P Affidavit copy of tender winning firm.
