ORDER

The 1st hearing held on 1st October, 2024 related to the APIC No-04/2024. The Complainant Shri Nabam Tai present during the hearing and the representative of PIO heard through online mode.

Heard both the parties.

The Complainant stated before the Commission that, the PIO has furnished the information(s) of only serial no. 1 as sought in his form 'A' application and rest information(s) pertaining to serial no. 2,3,4,5 & 6 have not been furnished to him till date.

After hearing the Complainant, and going through the RTI application of the Complainant the Commission explained to the Complainant that;

(i) The information(s) pertaining to serial no. 3, 4 & as sought by him in his form 'A' are not necessary or caused to be provided to him. Accordingly, the Complainant agreed with the Commission.

The Commission ordered;

- (i) The representative of PIO to furnish the information(s) of serial no. 2 & 6 out of all the information(s) sought in the form 'A' to the complainant on or before the next date of hearing. ***Failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.***
- (ii) Next date of hearing has been intimated to both the parties. No formal notice required to be issued.

The Commission ordered;

The next date of hearing be fixed on 21st November, 2024 at 10:30 PM (Morning)
