SUMMON NOTICE.

The 1st hearing was held on 3rd September, 2025 related to the **APIC No- 149/A/2025 (Appeal)**. The PIO-cum-EE(PWD), Bomdila Division attended the hearing through VC but the appellant Shri Mamu Sono found absent without any intimation to the Commission.

As per the order given by the First Appellate Authority-cum-SE (PWD), Rupa Circle dated 23/04/2024, on 2nd hearing both the parties were present. In its order stated that the representative of the PIO-cum-EE(PWD), Bomdila Division brought all the detailed information as sought by the appellant but without proper covering/forwarding letter. As agreed the appellant was directed to collect same from the office of the PIO-cum-EE (PWD), Bomdila Division and intimate to the First Appellate Authority within 15 (fifteen) days and also states that if no intimation is received from the appellant after fifteen days it will presume that the appellant is satisfied with the information furnished by the PIO and final order shall be passed related to the appellant's case.

In consideration with the FAA, last one more chance is given by the Commission today to collect the information from the PIO's office and intimate to the Commission. If no intimation is made on or before next date of hearing this appeal case will be heard in his absence. The Commission will presume that the appellant has no more interested to pursue the appeal case.

The PIO is directed to provide the information as sought by the appellant which is ready to be furnished.

The Commission adjourned the hearing and fixed next date of hearing on **03/11/2025 at 1030 hours.**
