ORDER

The 3rd hearing held on 6th March' 2025 related to the APIC No-1002/2023. The Appellant Shri Palen Laa is present. The PIO-cum-District Horticulture Officer (DHO), Raga, Kamle District, Govt. of Arunachal Pradesh, found absent without intimating to the Commission the reason for his inability to attend the hearing, which is unbecoming on the part of the PIO, who has to be reminded that, the PIO besides public duties, also has to attend Court hearings when an appeal is preferred against him as per the provisions of the **RTI, Act, 2005**, which is a statutory duty binding upon the PIO.

Heard the Appellant:

The Appellant stated before the Commission that the PIO has not furnished any of the information(s) sought by him in his Form-A application till date, despite order from the commission.

The Commission observes:

The PIO absent in the hearings consecutively 3 (three) times i.e on 07.11.2024, 19.12.2024 & 06.03.2025, despite of issuing summon/order and even after order for disciplinary action to be initiated against the PIO-cum-DHO, Raga, Kamle District, Govt. of Arunachal Pradesh.

The Commission observed:

Despite orders from the Commission to provide information(s) to the Appellant, and issuing warning summon and disciplinary action against the PIO, the PIO did not comply with the order of the Commission which is contempt of the order of this Court.

And therefore, the Commission hereby orders;

- (i) To issue bailable warrant of arrest to the PIO-cum-DHO, Raga, Kamle District, directing the officer in-charge of Raga Police Station, Kamle District, to execute and return the bailable warrant of arrest and produce the errant PIO on the next date of hearing i.e on **27th day of May, 2025' at 2:30 PM, without fail**, before this Court.
- (ii) The copy of this bailable warrant of arrest be served to the Superintendent of Police, Kamle District for compliance.
- (iii) The copy of this bailable warrant of arrest be served to the Deputy Commissioner, Kamle District for compliance.
- (iv) Notice need not be issued to the Appellant as he is personally present during the hearing before the Commission.

The Commission hereby orders;

The next date of hearing be fixed on 27th day of May' 2025 at 2.30 PM (A/Noon).
