ORDER

This is an appeal under Section 19(3) of RTI Act, 2005 filed by Shri Tania June, c/o of Post Office Naharlagun Arunachal Pradesh for non-furnishing of information by the State Public Information Officer (SPIO), Govt. of A.P. Department of PWD Capital Circle-cum-Coordination Training & Vigilance, Itanagar as sought by the Appellant under section 6(1) of RTI Act, 2005 vide Form-A Dated 13/03/2023 regarding appointment of under Junior Engineer (JE) Civil, Sports Quota / Handicapped/General of advertisement Date on 26th, 27th, 28th 29th September 2016.

The 5th hearing is held on 11th June, 2024 as scheduled. Shri S.T. Tara, the Public Information Officer (SPIO), Govt. of A.P. Department of PWD Capital Circle-cum-Coordination Training & Vigilance, Itanagar and the Appellant Shri Tania June are present. The PIO has submitted a copy of Treasury Challan being penalty under section 20(1) of the RTI Act, 2005. The PIO stated that the information are kept ready to be furnished except for certain information such as, Joining letter, educational qualification certificates etc. Those information are under the custody of the concern divisional public authority, under whom the officials have joined. As per the statement of the PIO, he has written several intimation to those divisions to furnish information available with them, so that he can further furnish to the Appellant. But they have not yet responded. However, the PIO has assured that he is ready to provide all the information available with him tomorrow i.e., on 12th June, 2024 at 03:00pm.

Regarding, document which are available with other divisions, the Commission directs the Appellant to make fresh application to those concern division's PIO, if he is interested in getting information. The Appellant is also directed to collect information from office of the PIO. The Appellant has agreed to visit the office of the PIO and collect the same. The court is adjourned for the next date of hearing.

Both the parties are directed to appear before the Commission's court in persons on the next date and time of hearing. In case the PIO fails to appear, the Commission shall be compelled to invoke recommendation of disciplinary action against the PIO under section 20(2) of the RTI Act, 2005. In case appellant remains absent the Commission shall dispose of the case without any further notice, presuming that the Appellant has received the information and is satisfied with the same as furnished by the PIO.

The next date of hearing is fixed on 30th July, 2024 (Tuesday) at 1030 hrs.

Therefore, Shri S.T. Tara, the State Public Information Officer (SPIO), Govt. of A.P. Department of PWD Capital Circle-cum-Coordination Training & Vigilance, Itanagaris hereby summoned to appear before this Court in person on the scheduled date and time without fail.
