This is for the 2<sup>nd</sup> time the appeal is heard today on 01-11-2024

In the first hearing both the PIO and Appellant were absent.

Therefore, the parties were warned that if they fail to appear in the next hearing i.e. today, the appeal shall be closed as not being pressed for hearing.

In today's hearing the Appellant is present but the PIO, o/o the E.E. (WRD), Bordumsa Division, Changlang District is again absent which has been viewed seriously by this Commission.
