**SUMMONS**

This is an appeal under Section 19(3) of RTI Act, 2005 received from Shri Nabam Tapak, Gyamar Hina for non-furnishing of information by the PIO O/o the Executive Engineer (RWD), Sagalee Division District Papum Pare, Arunachal Pradesh as sought for by the Appellant under section 6(1) (Form-A) of RTI Act, 2005.

This appeal is heard for the 3<sup>rd</sup> time today i.e on 23<sup>rd</sup> August 2024 as scheduled wherein the Appellant Shri Nabam Tapak was absent. However, Shri Gyamar Hina who was representing the Appellant was present. The PIO was absent again for the third time.

This Commission, taking serious view of the continued absence of the PIO in the hearing hereby issues a stern warning to the PIO for his absence and direct him to be present in the next hearing failing which necessary action will be initiated against him under the relevant provisions of RTI Act, 2005.
