ORDER.

The 1st hearing held on **18th June, 2024** related to the **APIC No-192/2024**. The Appellant Shri Nabam Tai present during the hearing but the PIO-cum- DFO heard through online mode.

Heard both the parties.

The Appellant stated before the Commission that he has not received any of the information from the PIO as sought in his form 'A' application.

On this, the PIO stated that the information are mostly ready with his office except pertaining to serial nos. (vii), (viii) & (x), for the reason that, while the application was filed, the plantation season was yet to come and so plantation could not be started and hence, the information as sought in serial nos. (vii), (viii) & (x) could not be provided to the Appellant.

The Commission after hearing both the parties directed the PIO to furnish all the information as applied by the Appellant in his application except for above mentioned serial nos. through post office within a week of this order and also a copy of intimation to the Commission for the informations to have been sent to the Appellant, **failing which necessary action shall be initiated against the PIO as per the provisions of RTI Act, 2005.**

Next date of hearing has been intimated to the Appellant. No formal notice required to be issued.
